The Government of the People's Republic of Bangladesh has received the loans from Japan International Cooperation Agency (JICA) towards the cost of the Dhaka Mass Rapid Transit Development Project, DMRTDP (Line-1) and intends to apply part of the proceeds towards the contract for Construction of Main Line and Stations (From the north of Rampura Station to Natun Bazar Station) resulting from the bidding for which this prequalification is conducted.
- 2. The Dhaka Mass Transit Company Limited (hereinafter referred to as "the Employer") now intends to prequalify firms for construction of main line for an underground length of 4.447 km and four (4) underground station (From the north of Rampura Station to Natun Bazar Station) in Dhaka. DMRTDP (Line-1) consists of two routes; Airport Route and Purbachal Route, which is a 17.9 km long underground and a 12.3 km elevated metro double track rail system with 12 underground stations and 7 viaduct stations and one maintenance depot having area of 35.9 ha. Packaging of this Project is described in Sub-Clause 1.1.2 of Section VI, Works Requirements.
- 3. It is expected that Invitation for Bids will be made in July 2022.
- 4. Prequalification will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Applicants from eligible source countries as defined in the Prequalification Document.
