Special Note:

- Every day 60 E-Passport Application will be received on First come First Serve basis.
- Conversion from Previous Handwritten passport and for the Irish Born young aged and Newborn First Passport application must be done through E-Passport System.
- Those who will not be able to submit the E-Passport application from pervious MRP they will be able to submit MRP Reissue application.

Following Consular Services will be provided on the day:

- 1) **E-Passport Application** from Previous HandWritten Passport/MRP/Newborn (Application to be received on the day and Delivery will be done by return post): The Applicant must have a NID or a 17 Digit Digital Birth Certificate. Detail process is given in this link: https://bhclondon.org.uk/e-passport-application
 - Note: The applicant must apply online and print the Submitted complete application with Barcode in the first page. The submitted complete application must be printed after opening with Adobe Reader. Printing the submitted application other than Adobe reader will fail in capturing data with the E-Passport Mobile Enrolement unit. So, it is mandatory to print the submitted application after opening with the Adobe Reader.

- Proof of address will be mandatory.
- Every day 60 E-Passport Application will be received on First come First Serve basis.
- 2) Machine Readable Passport (MRP Re-issue) Application: (Application to be received on the day and Delivery will be done by return post). The applicants will need to bring a self-addressed special delivery return envelope.
- 3) 'No Visa Required (NVR)':

(Application will be received on the day, but the NVR will be deilvered by post after 21 working days). The applicants will need to bring an envelope with return address.

- 4) Attestation of Power of Attorney:
 - (Receiving and delivery on the same day). Having a Valid Bangladeshi Passport is a mandatory requirement for those who will give POA.
- 5) **Birth Registration**: (Application will be received and delivery will be done over post). The applicant must bring the printed copy of the submitted online application form. The applicants will need to bring an envelope with return address.
- 6) Other attestation Service.

৬। পাওয়ার অফ এটর্নির জন্য সকল আবেদনকারীকে ব্যক্তিগত ভাবে উপস্থিত হতে হবে। পাওয়ার অফ এটর্নির নির্ধারিত ফরম্যাট বাংলাদেশ হাইকমিশন, লন্ডনের ওয়েবসাইট দ্রষ্টব্য। Power of Attorney (POA) করার জন্য মেয়াদসহ বাংলাদেশি পাসপোর্ট থাকা প্রয়োজন হবে।

৮। নো ভিসা রিকোয়ার্ড (NVR), মেশিন রিডেবল পাসপোর্ট রিইস্যু, নতুন পাসপোর্ট এবং বার্থ সার্টিফিকেট আবেদনকারীগণকে আবেদনের সময় অবশ্যই রিটার্ন এড়েসসহ ইনভেলপ নিয়ে আসতে হবে।

৯। সকল সেবার খরচ কার্ডের মাধ্যমে নেয়া হবে। রিটার্ন ইনভেলপে পরবর্তীতে পাসপোর্ট লন্ডন থেকে পোস্ট করার জন্য শুধু পোস্টাল খরচ ইউরো/পাউন্ডে ক্যাশ নেয়া হবে। পোস্টাল খরচ ব্যতীত কোন সেবার জন্য ক্যাশ গ্রহণ করা হবে না।

Documents Required for the Services those will be provided.

Please read the instructions carefuly and prepare the documents before arriving for service.

For E-Passport Application:

Please follow https://bhclondon.org.uk/e-passport-application this link for E-Passport application preparation and Documents requirement.

Impotant instructions regarding E-Passport:

- 1. The application may not be success if the sufficient documents are not produced during the enrolement. Hence, it is mandatory to bring all the required documents specified on the above link.
- 2. For New E Passport application, Conversion of MRP to E-Passport and New E-Passport from Previous Handwritten passport, for all the cases the NID/BRC must have the exact same data as per the application. As such, while applying, it is mandatory to check all data matches together. For BRC check please check from this link whether the BRC is online verifieable or not. The online verifiable data must have English BRC data. Please check from this link: https://everify.bdris.gov.bd/
- 3. The applicant must apply online and print the Submitted complete application with Barcode in the first page. The submitted complete application must be printed after opening with Adobe Reader. Printing the submitted application other than Adobe reader will fail in capturing data with the E-Passport Mobile Enrolement unit. So, it is mandatory to print the submitted application after opening with the Adobe Reader.
- 4. Proof of address will be mandatory.
- 5. The applicants must bring the clear photocopy of the supporting documents.

For Machine Readable Passport (MRP) Reissue:

- Filled in 'MRP' Reissue: form(https://bhclondon.org.uk/assets/theme/file/MRP_reissue.pdf).
- 2. Copy of previous MRP. You also need to bring previous MRP. If someone lost their MRP a lost report from the local police and the copy of lost MRP will be required.
- 3. Students must bring their original student ID or CAS letter in order to claim student discount. A photocopy is also required.
- 4. We will only accept the photo change request of the applicants who are upto 6 years of age. Any photo/biometric change request for a person over 6 years will not be possible during surgery. Such photo or biometric change request must be done in the High Commission.

For No Visa Required (NVR) for the First time:

- 1. Filled in and printed 'No Visa Required' form(https://www.visa.gov.bd/) and signed.
- 2. One photograph.
- 3. Photocopy of Irish/UK Passport (name page).
- 4. Bangladeshi passport with photocopy (page 1-3)/ Bangladeshi Birth Certificate/Bangladeshi National ID Card.

For No Visa Required (NVR) who has previous NVR:

- 1. Filled in and printed 'No Visa Required' form(https://www.visa.gov.bd/) and signed.
- 2. One photograph.
- 3. Photocopy of the old Irish/UK Passport (name and biometric page) and NVR page.
- 4. The applicant must bring the Old Irish/UK passport while submitting the application.

For First NVR for Child:

- 1. Filled in and printed 'No Visa Required' form (https://www.visa.gov.bd/) and signed by parent.
- 2. One photograph.
- 3. Child's Birth Certificate with parents' name appearing on the certificate along with photocopy.
- 4. Parents' Bangladeshi passport Or, Bangladeshi Birth Certificate/NID.

For Spouse of Bangladeshi National:

- 1. Filled in and printed 'No Visa Required' form (https://www.visa.gov.bd/) and signed.
- 2. One photograph.
- 3. Marriage certificate.
- 4. Bangladeshi Passport Or, Bangladeshi Birth Certificate/NID of the Spouse.
- 5. Both the Spouse must attend for an interview.

For Power of Attorney:

- 1. Properly formatted POA document. See this https://bhclondon.org.uk/power-of-attorney
- 2. Valid Bangladeshi passport of each POA executants.
- 3. One photograph of each person (those who are giving and those who are receiving the power).
- 4. Physically presence of all persons (those who are giving power-of-attorney) for signing in front of the High Commission officials.
- 5. All the land related documents including Khatian and Dalils. Wasrish/Succession Certificate in case of the property belongs to the Ancestors.

For Attestation:

- 1. Documents originated in Bangladesh must be attested by the Ministry of Foreign Affairs. Dhaka.
- 2. For the attestation of a photocopy of an original the document, the applicant should submit the photocopy along with the original document.
- 3. For attestation of signature, the applicant must come in person with a valid passport and a passport size photograph. The applicant needs to sign in a prescribed form in front of the consular officer.

Birth Certificate:

- 1. Online Application must be submitted from this link https://bdris.gov.bd/br/application. After submission you will have to print the submitted application.
- 2. A copy of previous passport will be required.
- 3. A photo will be required.
- 4. If the Birth Certificate is for Irish born child, then childs Irish Birth Certificate and parents Bangladeshi Passport will be required.

Fee

The fee will be taken by POS machine from the applicants Bank Card. No payment will be taken by cash.
